The Institute of Economic Growth (IEG), Delhi invites online applications for one post at the rank of Professor (General Category) at Pay Matrix Level 14 for the Sociology Unit of the Institute. The application is to be submitted by **October 31, 2022**. The position carries usual allowances admissible from time to time at the Institute.

The Institute is an autonomous research and training organization established in 1952. The Institute's faculties work in several areas of Economics, Sociology and Demography. The Sociology unit in IEG is funded by the Indian Council of Social Science Research (ICSSR), Ministry of Education, Government of India.

Research within the Sociology Unit has focused on a range of topics including the comparative study of development; urban and rural transformation; labour and migration; professionals and other middle-class elites; disciplinary histories; religion, secularism and modernization; social policy in respect to education; language and Indian democracy; social ecology and food studies. The Unit also publishes the reputed peer-reviewed journal, Contributions to Indian Sociology.

Minimum Qualification
Eligibility (A or B)

- A. (i) An eminent scholar having a Ph.D. degree in Sociology/Social Anthropology, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per criteria given in Appendix –II, Table 2.
- (ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor and /or research experience at the equivalent level at the University/National Level Institutions with evidence of having guided doctoral candidate.

OR

- B. An outstanding professional, having a Ph.D. degree in Sociology/Social Anthropology, from any academic institutions (not included in "A" above)/industry, who has made a significant contribution to the knowledge in Sociology/Social Anthropology, supported by documentary evidence provided he/she has ten years' experience.

General Instructions for Candidates

1. The application has to be filled out online on the Institute's website i.e., www.iegindia.org under the 'Career' web link along with the instant advertisement. Applications should be submitted within the prescribed time limit indicated in the advertisement.
2. Applicants are required to download the filled-up application form and send it along with self-attested educational qualification certificates and testimonials (hard copy). Please

- also send the names of three references and copies of the ten best publications by post. On the top of the envelope, please write “Application for the Post of Professor, Sociology Unit, addressed to the Director, Institute of Economic Growth, University of Delhi Enclave, North Campus, Delhi – 110007. The hard copy of the application should reach by **November 11, 2022**.
3. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel.
 4. Persons of Indian Origin (PIO) or Overseas Citizens of India (OCI), if selected, the appointment will be on contract for up to three years subject to clearance from the Govt. of India before he/she can join the Institute. Extension beyond three years will be subject to a review process and necessary approvals may be required.
 5. Applications received without complete information shall be rejected.
 6. Consequent to the adoption of self-certification provisions as required by the Government of India, the Institute shall process the applications entirely on the basis of information/documents submitted by the candidates duly self-attested. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall be the sole responsibility of the candidate.
 7. Candidate called for an interview should report along with all the testimonials/certificates in original along with photo ID.
 8. Candidates should possess the prescribed qualification and experience as of the closing date of application. Candidates are required to produce specific certificates as per eligibility conditions.
 9. Further, merely fulfilling the minimum qualifications or the eligibility criteria does not entitle a candidate to be necessarily considered or called for an interview. More stringent criteria may be applied for short-listing the candidates to be called for an interview.
 10. No correspondence or personal inquiries shall be entertained by the Institute. The candidates may visit the Institute's website: www.iegindia.org for any information from the Institute including interview calls if any. Correspondence, if any, in this matter will be sent to the e-mail ID of the candidate. Any corrigendum/addendum in this regard shall also be posted on the Institute’s website only.
 11. Applications that which do not meet the criteria given in this advertisement and/or incomplete applications are liable to be summarily rejected.
 12. The Institute reserves the right not to fill the above position if circumstances so warrant, without assigning any reason.
 13. Outstation candidates called for a physical interview will be reimbursed for airfare as per the institute’s rules.
