- (ii) Demonstrable track record of research and policy analysis in the areas of health economics/public health with a proven focus on empirical research. At least 7 publications in peer-reviewed economics/public health journals, with a minimum of 3 in the last 5 years
- (iii) A minimum of 12 years of experience after Ph.D. This can be relaxed in special cases for deserving candidates.

Note: In case candidate is not found suitable for the post of Associate Professor against the above, the Institute may consider appointing Assistant Professor at Pay Matrix Level 10 to 12 as per 7th CPC with a minimum of 3 years and above experience after Ph.D.
