Minimum Qualification

Eligibility:

- (i) A good academic record, with a Ph.D. Degree in Economics/Agricultural-Economics/Time Series Analysis/Applied Economics.
- (ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- (iii) A minimum of eight years of experience of teaching and/or research in an academic/research position equivalent to that of an Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix-II, Table 2.
- Age: The candidates should preferably be below 45 years. (relaxable by the Selection Committee in deserving cases)

General Instructions for Candidates

- 1. The application has to be filled out online on the Institute's website i.e. www.iegindia.org under the "Career" web link along with the instant advertisement. Applications is to be submitted by January 15, 2023.
- 2. Applicants are required to download the filled up application form and send it along with selfattested educational qualification certificates and testimonials (hard copy). Please also send the names of three references and copies of ten best publications by post. The hard copy of the application should reach by January 31, 2023.
- 3. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel.

Persons of Indian Origin (PIO) or Overseas Citizens of India (OCI), if selected, the appointment will be on contract for up to three years subject to clearance from the Govt. of India before he/she can join the Institute. Extension beyond three years will be subject to a review process and necessary approvals may be required.
