Advertisement for the post of Associate Professor (Scheduled Caste Category)

The Institute is an autonomous research and training organization established in 1952. The Institute's faculties work in several areas of Economics, Sociology, and Demography. The Institute of Economic Growth (IEG), Delhi invites online applications for one post of **Associate Professor (Scheduled Caste Category)** on regular basis (against leave vacancy) at Pay Matrix Level-13A (131100-216600) in the **Agriculture Economic Research Unit** at the Institute. The application is to be submitted by January 15, 2023. The position carries usual allowances admissible from time to time at the Institute.

Minimum Qualification

Eligibility:

- (i) A good academic record, with a Ph.D. Degree in Economics/Agricultural-Economics/Time Series Analysis/Applied Economics.
- (ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- (iii) A minimum of eight years of experience of teaching and/or research in an academic/research position equivalent to that of an Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix-II, Table 2.

Age: The candidates should preferably be below 45 years. (relaxable by the Selection Committee in deserving cases)

General Instructions for Candidates

1. The application has to be filled out online on the Institute's website i.e. www.iegindia.org under the "Career" web link along with the instant advertisement. Applications is to be submitted by **January 15, 2023**.
2. Applicants are required to download the filled up application form and send it along with self-attested educational qualification certificates and testimonials (hard copy). Please also send the names of three references and copies of ten best publications by post. On top of the envelope, please write "Application for the Post of Associate Professor, Agriculture Economic Research Unit, addressed to the Director, Institute of Economic Growth, University of Delhi Enclave, North Campus, Delhi-110007. The hard copy of the application should reach by **January 31, 2023**.
3. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel.
4. Persons of Indian Origin (PIO) or Overseas Citizens of India (OCI), if selected, the appointment will be on contract for up to three years subject to clearance from the Govt. of India before he/she can join the Institute. Extension beyond three years will be subject to a review process and necessary approvals may be required.

5. Application received without complete information shall be rejected.
6. Consequent to the adoption of self-certification provisions as required by the Government of India, the Institute shall process the applications entirely on the basis of information/documents submitted by the candidates duly self-attested. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall be the sole responsibility of the candidate.
7. Candidate called for interview should report along with all the testimonials/certificates in original along with photo ID.
8. Candidates should possess the prescribed qualification and experience as of the closing date of application. Candidates are required to produce specific certificates as per eligibility conditions.
9. Further, merely fulfilling the minimum qualifications or the eligibility criteria does not entitle a candidate to be necessarily considered or called for an interview. More stringent criteria may be applied for short-listing the candidates to be called for an interview.
10. The Institute will communicate only with short-listed candidates. No correspondence or personal enquiries shall be entertained by the Institute. The candidates may visit the Institute's website: www.iegindia.org for any information from the Institute including interview calls if any. Correspondence, if any, in this matter will be sent to the e-mail ID of the candidate. Any corrigendum/addendum in this regard shall also be posted on the Institute's website only.

12. Applications which do not meet the criteria given in this advertisement and/or incomplete applications are liable to be summarily rejected.
13. The Institute reserves the right not to fill the above position if circumstances so warrant. The Director, IEG, is competent to decide not to fill up the above posts without assigning any reason. The Institute can also consider suitable candidates who may not have applied. The decision of the Selection Committee shall be final.
14. Candidates short listed for the physical interview shall be reimbursed round-trip economy class airfare within India. No local conveyance will be provided.
