Essential Qualifications:

- i) The candidate should have good academic record, with at least second class Post Graduate Degree in Demography/Population Studies/Statistics/Economics/Mathematics/Psychology/Sociology/Anthropology/Development Studies/Geography/Social Work from a recognized Institute/University.
- ii) **Knowledge in Computer Applications:** Knowledge of quantitative techniques and experience in using computer software such as **STATA/SPSS/R/EVIEWS** is desired. Knowledge of large-scale datasets like NFHS, LASI, Census, NSSO, etc. is preferred.
- iii) **Work Experience:** Preference will be given to candidates with relevant experience in collection/analysis of data/conducting of field surveys and having work experience in the areas of Reproductive and Child Health and issues relating to NHM and other national health programmes. Experience in Monitoring and Evaluation activities is strongly preferred. Research experience in handling mixed qualitative and quantitative data is desirable. Candidates with a strong command in M&E report writing are encouraged to apply.

2. Applicants are required to download the filled-up application form and send it along with self-attested educational qualification certificates and testimonials (hard copy). Please also send the application by post. On the top of the envelope, please write "Application for the Post of Research Investigator, Population Research Centre of the Institute addressed to the Director, Institute of Economic Growth, University of Delhi Enclave, North Campus, Delhi-110007. The hard copy of the application should reach by **1st February 2023**.
3. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel. Salary of the candidate working in pay scale will be protected, if selected.
4. Applications received without complete information shall be rejected.
5. Consequent to the adoption of self-certification provisions as required by the Government of India, the Institute shall process the applications entirely on the basis of information/ documents submitted by the candidates duly self-attested. In case the information/ documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall be the sole responsibility of the candidate.
6. Candidates called for an interview should report along with all the testimonials/certificates in original along with photo ID.
7. Candidates should possess the prescribed qualification and experience as of the closing date of application. Candidates are required to produce specific certificates as per eligibility conditions.
