The Institute of Economic Growth (IEG), Delhi invites online applications for one post of Assistant Professor (OBC) Category at Pay Matrix Level-10 in the Agriculture Economics Research Unit at the Institute for a period of one year, position is likely to continue. The position carries usual allowances admissible from time to time at the Institute.

The Institute is an autonomous research and training organization established in 1952. The Institute's faculties work in several areas of Economics, Sociology and Demography.

Minimum Qualification

Essential Qualifications:

- (i) Ph.D. degree in Economics/Agriculture Economics/Applied Economics.
- (ii) Demonstrable track record of research and policy analysis in the areas of agriculture.
- (iii) A minimum of 3 years of experience after Ph.D. Exceptional candidates with less than 3 years experience will also be considered.
- (iv) At least 2 very good publications in peer reviewed economics/agriculture economics journals.

Desirable:

- (i) Teaching experience desirable.

Age: Below 35 years (relaxable by Selection Committee in Deserving Cases).

General Instructions for Candidates

1. The application has to be filled out online on the Institute's website i.e. www.iegindia.org under the "Career" web link along with the instant advertisement. Applications is to be submitted by **March 10, 2023**.
2. Applicants are required to download the filled-up application form and send it along with self-attested educational qualification certificates and testimonials (hard copy). Please also send the names of three references and copies of the two best publications by post. On the top of the envelope, please write "Application for the Post of Assistant Professor (OBC), Agriculture Economics Research Unit, addressed to the Director, Institute of Economic Growth, University of Delhi Enclave, North Campus, Delhi-110007. The hard copy of the application should reach by **March 20, 2023**.
3. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel.
4. Application received without complete information shall be rejected.

5. Consequent to the adoption of self-certification provisions as required by the Government of India, the Institute shall process the applications entirely on the basis of information/documents submitted by the candidates duly self-attested. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall be the sole responsibility of the candidate.
6. Candidate called for interview should report along with all the testimonials/certificates in original along with photo ID.
7. Candidates should possess the prescribed qualification and experience as of the closing date of application. Candidates are required to produce specific certificates as per eligibility conditions.
8. Further, merely fulfilling the minimum qualifications or the eligibility criteria does not entitle a candidate to be necessarily considered or called for an interview. More stringent criteria may be applied for short-listing the candidates to be called for an interview.
9. The Institute will communicate only with short-listed candidates. No correspondence or personal enquiries shall be entertained by the Institute. Correspondence, if any, in this matter will be sent to the e-mail ID of the candidate. Any corrigendum/addendum in this regard shall also be posted on the Institute's website only.
