- 4) Unsigned quotation and documents will be rejected. Please submit the quotation with offer letter on Company/Firm's letter-head.
- 5) Guarantee/Warranty should be mentioned separately for the products utilized.
- 6) Applicable taxes will be deducted as per prevailing rates and as per notification of the Govt. of India.
