The Institute of Economic Growth (IEG), Delhi invites online applications for one post at the rank of Professor (General Category) at the Pay Matrix Level-14 at the Indian Economics Service Unit on a rolling basis. The position carries usual allowances admissible from time to time at the Institute.

The Institute is an autonomous research and training organization established in 1952. The Institute's faculties work in several areas of Economics, Sociology, and Demography.

Minimum Qualification

Eligibility (A or B)

A. (i) An eminent scholar having a Ph.D. degree in Economics, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in peer-reviewed or UGC-listed journals and a total research score of 120 as per criteria given in Appendix-II, Table 2 (enclosed).

(ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor and/or research experience at an equivalent level at the University/National Level Institutions with evidence of having guided doctoral candidates.

Or

B. An outstanding professional, having a Ph.D. degree in Economics, from any academic institution (not included in A above)/industry, who has made a significant contribution to knowledge in Economics, supported by documentary evidence provided he/she has ten years of experience.

Note:

- 1) **Age:** The candidates should preferably be below 45 years (relaxable by Selection Committee in deserving cases).
- 2) Candidates are required to submit self-declaration about their API scores in the prescribed format available on the website.

Additional Requirement

Will need to teach applied econometrics, (including panel data and time series) in the training programmes for the Indian Economic Service held at the Institute. Preferably should also be able to teach one or more of macroeconomics, micro-economics and public economics. The applicant should have extensive teaching experience at the post-graduate level. Candidates, who have contributed to educational innovation, the design of new curricula and courses and the technology-mediated teaching-learning processes, will be preferred. The candidates should preferably be below 45 years.

General Instructions for Candidates

1. The application has to be filled out online on the Institute's website i.e. www.iegindia.org under the "Career" web link along with the instant advertisement. Applications will be processed on a rolling basis. The first set of applications needs to be submitted by **March 25, 2023**. The second set of applications needs to be submitted by **April 30, 2023**.
2. If the position is not filled by the second deadline, the new deadline will be intimated through the IEG website. The hard copy of the application should reach to the Institute within 10 days from the close of the online application as indicated at **SI No.1 above**.
3. Applicants are required to download the filled-up application form and send it along with self-attested educational qualification certificates, testimonials (hard copy), and API Scores in the prescribed format. Please also send the names of three referees and copies of your ten best publications by post. On the top of the envelope, please write "**Application for the Post of Professor (Gen.), IES Unit**" addressed to the Director, Institute of Economic Growth, University of Delhi Enclave, North Campus, Delhi-110007.

Those who have applied with reference to the previous advertisement with last dated October 31, 2022, need not apply again. Their applications will be considered with other applications.

4. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel.
5. Persons of Indian Origin (PIO) or Overseas Citizens of India (OCI), if selected, the appointment will be on contract for up to three years subject to clearance from the Govt. of India before he/she can join the Institute. Extension beyond three years will be subject to a review process and necessary approvals may be required.
6. Application received without complete information shall be rejected.

7. Consequent to the adoption of self-certification provisions as required by the Government of India, the Institute shall process the applications entirely on the basis of information/ documents submitted by the candidates duly self-attested. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall be the sole responsibility of the candidate.
8. Candidates called for an interview should report along with all the testimonials/certificates in original along with photo ID.
9. Candidates should possess the prescribed qualification and experience as of the closing date of application. Candidates are required to produce specific certificates as per eligibility conditions.
10. Further, merely fulfilling the minimum qualifications or the eligibility criteria does not entitle a candidate to be necessarily considered or called for an interview. More stringent criteria may be applied for short-listing the candidates to be called for an interview.
11. No correspondence or personal enquiries shall be entertained by the Institute. The candidates may visit the Institute's website: www.iegindia.org for any information from the Institute including interview calls if any. Correspondence, if any, in this matter will be sent to the e-mail ID of the candidate. Any corrigendum/addendum in this regard shall also be posted on the Institute's website only.
12. Applications which do not meet the criteria given in this advertisement and/or incomplete applications are liable to be summarily rejected.
13. The Institute reserves the right not to fill the above position if circumstances so warrant. The Director, IEG, is competent to decide not to fill up the above posts without assigning any reason.
