Minimum Qualification

Eligibility:

- (i) A good academic record, with a Ph.D. Degree in Economics/Applied Economics.
- (ii) A Master's Degree in the subject of Economics/Agricultural Economics, Development Economics/Statistics with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- (iii) A minimum of eight years of experience of teaching and/or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix-II, Table 2.

Age: The candidates should preferably be below 40 years (relaxable in deserving cases).

General Instructions for Candidates

- 1. The application has to be filled out online on the Institute's website i.e. www.iegindia.org under the "Career" web link along with the instant advertisement. Application is to be submitted by May 10, 2023.
- 2. After submission of online application, applicants are required to download the filled-up application form and send it along with self-attested educational qualification certificates and testimonials (hard copy). Also require to send the names of three references and copies of the five best publications and API score form duly filled in by post.
