- 6) Applicable taxes will be deducted as per prevailing rates and as per notification of the Govt. of India.
- 7) The manufacturer/Distributor/Dealer will be responsible for the safe supply and installation of the items at the required premises of the Institute with their quoted price only. No extra amount will be paid for the transportation/cartage and/or installation.
