- (ii) Evidence of research experience in health economics and policy, preferably with an added focus on health financing, public finance, and budget data
- (iii) Strong quantitative skills with ability to work on large datasets
- (iv) At least 2 publications in peer-reviewed economics/public health journals

**General Instructions for Candidates**

1. The application has to be filled out online on the Institute’s website i.e. [www.iegindia.org](http://www.iegindia.org) under the “Career” web link with the instant advertisement. The application is to be submitted by **December 22, 2023**.
2. After submission of the online application, the applicants are required to download the filled-up application form and send it along with self-attested educational qualification certificates and testimonials (hard copy). Please also send the names of three references and copies of the best publications (maximum 3) by post. On the top of the envelope, please write “**Application for the post of Assistant Professor, NIHR Project** at the IEG addressed to the Director, Institute of Economic Growth, University of Delhi Enclave, North Campus, Delhi – 110007. The hard copy of the application should reach by **December 29, 2023**.”
3. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel. Salary of the candidate working in pay scale will be protected, if selected.
4. Persons of Indian Origin (PIO) or Overseas Citizens of India (OCI), if selected, the appointment will be on contract for up to three years subject to clearance from the Govt. of India before he/she can join the Institute. Extension beyond three years will be subject to a review process and necessary approvals.

5. Applications, which do not meet the criteria given in this advertisement and/or incomplete applications, are liable to be summarily rejected.
6. Consequent to the adoption of self-certification provisions as required by the Government of India, the Institute shall process the applications entirely on the basis of information/documents submitted by the candidates duly self-attested. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall be the sole responsibility of the candidate.
7. Candidates called for an interview should report along with all the testimonials/certificates in original along with photo ID.
8. Candidates should possess the prescribed qualification and experience as of the closing date of application. Candidates are required to produce specific certificates as per eligibility conditions.
9. Merely fulfilling the minimum qualifications or the eligibility criteria does not entitle a candidate to be necessarily considered or called for an interview. More stringent criteria may be applied for short-listing the candidates to be called for an interview.
10. The Institute will communicate only with short-listed candidates. No correspondence or personal inquiries shall be entertained by the Institute.
