**Essential Qualifications:**

- (i) Ph.D. degree in Economics/Applied Economics/Agriculture Economics.
- (ii) Demonstrable track record of research and policy analysis in the areas of agriculture.
- (iii) At least one very good publication in peer reviewed economics/agriculture economics journals.

**General Instructions for Candidates**

1. The application has to be filled out online on the Institute's website, i.e., [www.iegindia.org](http://www.iegindia.org) under the "Career" web link along with the instant advertisement. The application is to be submitted **online by March 31, 2024 followed by a hard copy along with all essential documents at IEG by April 12, 2024.**
2. After submission of the online application, applicants are required to download the filled-up application form and send it along with self-attested educational qualification certificates and testimonials (hard copy). Also required to send the names of three references and copies of the best publications (maximum-3) by post.

On the top of the envelope write "Application for the post of Assistant Professor (OBC Category), Agricultural Economics Research Unit, addressed to the Director, Institute of Economic Growth, University of Delhi Enclave, North Campus, Delhi-110007. The hard copy of the application should arrive by **April 12, 2024.**

3. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel. The salary of the candidate working in the pay scale will be protected, if selected.
4. Persons of Indian Origin (PIO) or Overseas Citizens of India (OCI), if selected, the appointment will be on contract for up to three years subject to clearance from the Govt. of India before he/she can join the Institute. Extension beyond three years will be subject to a review process and necessary approvals.
5. Applications, which do not meet the criteria given in this advertisement and/or incomplete applications, are liable to be summarily rejected.
6. Consequent to the adoption of self-certification provisions as required by the Government of India, the Institute shall process the applications entirely based on information/ documents submitted by the candidates duly self-attested. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall be the sole responsibility of the candidate.
7. Candidates called for interview should report along with all the testimonials/certificates in original along with photo ID as per eligibility conditions.
8. Candidates should possess the prescribed qualification and experience as of the closing date of application.
9. Further, merely fulfilling the minimum qualifications or the eligibility criteria does not entitle a candidate to be necessarily considered or called for an interview. More stringent criteria will be applied for short-listing the candidates to be called for an interview.
10. The Institute will communicate only with short-listed candidates. No correspondence or personal inquiries shall be entertained by the Institute.
