The initial tenure for the above positions is for a period of one year but can be extended, subject to availability of funding and satisfactory performance of the candidate till three years.

Job Description:

The job involves collection of primary and secondary data, analysis, interpretation and drafting of research reports. Candidates should be willing to travel.

Essential Qualifications:

- i) The candidate should have a good academic record, with at least a second-class Master's degree in Economics/ Econometrics/ Agricultural Economics/ Statistics/ Agricultural Statistics from an Indian University or equivalent degree from a foreign University.
- ii) Proficiency in data processing/ analysis and computer skills. In particular, proficiency in software such MS-office, E-Views, Stata, R etc.
- iii) A minimum of one-year experience in teaching/ research in Economics / Statistics/ Agricultural Economics in a recognized Institution or University is necessary. In particular, experience in organizing and conducting rural economic investigations/ surveys and handling primary and secondary data on agriculture or related subjects is preferred.

Desirable Qualifications:

- i) M.Phil/Ph.D. in Economics/Agricultural Economics.
- ii) Ability to draft research reports.
