Essential Qualifications:

- Good academic record with at least a Second Class M.A./M.Sc. in Economics.
- Candidates should have Ph.D. in Economics.
- Familiarity with quantitative techniques and ability to work with macro– economic datasets.
- High familiarity with STATA and EVIEWS and at least one software: R or Python.

Selected candidates would be expected to travel to conduct primary survey, if such a need arises.

Demonstrable track record of research and policy analysis in the areas of Macro-economics, Economic Growth, International Finance, Macro-Modelling and Forecasting is preferable. Knowledge of Machine Learning Techniques and their application would be an added advantage.

1. The application has to be filled out online on the Institute's website, i.e., <u>www.iegindia.org</u> under the "Career" web link along with the instant advertisement. Applications are to be submitted by **August 12, 2024.**

2. After submission of applications, the applicants are required to download the filled-up application form and send it along with self-attested educational qualification certificates and testimonials (hard copy). On the top of the envelope, please write "Application for the post of Junior Consultant for the RBI Endowment Chair Unit". The envelope should be addressed to "The Director, Institute of Economic Growth, University of Delhi Enclave, North Campus, Delhi–110007". The hard copy of the application should arrive by **August 22, 2024.**

3. Candidates working in Government/Autonomous Bodies/Universities/ Institutions of repute must send the hard copy of the application through the proper channel.

4. Persons of Indian Origin (PIO) or Overseas Citizens of India (OCI), if selected, the appointment will be on contract for up to three years subject to clearance from the Govt. of India before he/she can join the Institute. Extension beyond three years will be subject to a review process and necessary approvals.

5. Application received without complete information shall be rejected. Applications that do not meet the criteria given in this advertisement and/or incomplete applications are liable to be summarily rejected. Corrigendum/addendum (if any) shall be posted on the Institute's website only.

6. Consequent to the adoption of self-certification provisions as required by the Government of India, the Institute shall process the applications entirely based on information/documents submitted by the candidates duly self-attested. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall be the sole responsibility of the candidate.

7. The candidate called for an interview should report along with all the testimonials/certificates in original along with a photo ID.

8. Candidates should possess the prescribed qualification and experience as of the closing date of application.

9. Further, merely fulfilling the minimum qualifications or the eligibility criteria does not entitle a candidate to be necessarily considered or called for an interview. More stringent criteria may be applied for short-listing the candidates to be called for an interview.

10. Other things being equal, SC/ST/OBC candidates will be preferred.
