# **Funded Research Programs Completed**

➤ The Planning Commission Funded Macro-Econometric Modelling Program (2000 to 2015)

I have worked for almost 15 years with the Perspective Planning Division of the Indian Planning Commission on an on-going macro-modelling exercise which provided policy analysis and forecasts on various aspects of the Indian economy. These simulations and forecasts were used by the Planning Commission as inputs for the successive five-year plans of the government. One version of this model was published in Kirit Parikh (Eds.) *Macro-Modelling for the Eleventh Five Year Plan of India*.

The University of Manchester sponsored Program, 'Political Determinants of Economic Growth' (2011 to 2019)

This research program moves beyond policies and institutions that are conducive to inclusive growth, towards an analysis of how political processes shape the emergence and maintenance of these policies and institutions. It undertakes an exploration of the political and institutional reasons why growth sometimes

accelerates from stagnation/crisis to stable/miracle growth, and may then be either sustained for long periods or decelerate/collapse suddenly.

# **Funded Research Projects Completed**

 The Asian Productivity Organization (APO, Tokyo) sponsored project 'Policy Study on Productivity-enhancing Structural Transformation in LMICs'.

This study is based on eleven lower-middle-income Asian economies, namely Bangladesh, Cambodia, India, Indonesia, Lao PDR, Mongolia, Nepal, Pakistan, the Philippines, Sri Lanka, and Vietnam. The aim of the study is to quantitatively assess the extent of structural transformation and within-sector productivity growth in these countries, examining their respective contributions to overall growth. Additionally, the labor productivity growth patterns within different subsectors of the economy are analysed in some detail.

 The World Bank sponsored project 'India Country Economic Memorandum Convergence Study'.

This project studies the growth of sub-national regions in India within the theoretical framework of economic convergence. Specifically, it looks at this issue both for the Indian states as well as for districts within these states. The relationship between convergence at the state and district level are investigated. Finally, the study attempts to identify structural and policy variables that drive these results.

 The Finance Ministry of India sponsored project, 'Utilizing Pensions and Insurance Pools in Infrastructure Investments'.

This project undertakes a comparative study of the pension and insurance ecosystems in India and select countries like Canada, Australia, United Kingdom, China, Brazil, United States, South Korea and Singapore, with the goal of

identifying key learnings and best practices that channel funds towards Infrastructure.

 The UNU-WIDER sponsored project, 'The Developer's Dilemma: Structural Transformation, Inequality and Inclusive Growth'.

This project attempts to identify the alternate trajectories that have been taken by developing countries in order to balance between structural transformation and inclusiveness.

The GDN sponsored project, 'Shocks, Economic Growth and the Indian Economy'.

Funded by the governments of UK, the Netherlands, the IMF and the World Bank this was an international project to obtain perspectives of academics in low-income countries on the effectiveness and scope for improvement of macroeconomic policy in their economies.

The World Bank sponsored project 'GSDP Forecasting and Analysis Report'.

This was a pioneering study to construct the first macro-econometric models for the states of India.

The National Institute of Rural Development sponsored project, 'Growing Disparities in Uttarakhand'.

This project examined the sources of inequality of income opportunity in the Himalayan state of Uttarakhand based on data from a survey of clusters in disparate geographical regions of the state.

 The Uttaranchal Government sponsored project, 'Uttaranchal Approach to the Eleventh Plan'

This project analyzed the problems of a relatively new state in the hills, Uttarakhand, and particularly the reasons for stagnation in the hilly regions of the state. It also examined the policy priorities that could enable the state to achieve inclusive growth.
